STABILITY: Stable.

SECTION 6 – STORAGE AND HANDLING INFORMATION

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORING:

When spraying more than one-half can continuously or more than one can consecutively, use NIOSH-approved respirator.

Store at temperatures below 120°F. KEEP AWAY FROM HEAT, SPARKS, OR OPEN FLAME. KEEP AWAY FROM CHILDREN.

For industrial and institutional use only. For use by trained personnel only. Keep container closed during storage.

SECTION 7 – HEALTH HAZARDS AND FIRST AID**EFFECTS OF OVER-EXPOSURE**

SKIN: Skin irritant. Will cause de-fatting of skin. Effects are reversible.

EYES: Eye irritant. Will cause redness and burning sensation.

INHALATION: *Effects of over-exposure include:* Irritation of respiratory tract, headache, dizziness, nausea, and loss of coordination. Extreme over-exposure may result in unconsciousness and possibly death.

INGESTION: Aspiration hazard if swallowed.

FIRST AID PROCEDURES

SKIN: Immediately flush exposed area with water for at least 15 minutes. If irritation persists, get medical attention. Remove contaminated clothing and launder before reuse.

EYES: Immediately flush with large quantities of water for at least 15 minutes, lifting upper and lower eyelids occasionally. Seek medical attention.

INHALATION: Remove person to fresh air. If irritation persists, give oxygen, get medical attention.

INGESTION: *DO NOT INDUCE VOMITING.* Seek medical attention immediately.

NOTE: *NEVER* give anything by mouth to an unconscious or convulsing victim. Keep person warm and quiet.

RESPIRATORY PROTECTION: None normally required.

VENTILATION: Provide local exhaust.

PROTECTIVE GLOVES: None required if spraying.
